Subject: Export Control Notice

This notice is to inform you that Restek must be in compliance with all export laws and regulations of the United States Government, and that certain requirements of these laws and regulations pertaining to prohibited sales extend to all Restek subsidiaries, distributors and customers. Attached you will find a summary of these controls as well as restricted countries, entities or individuals and end uses.

As our distribution partner or customer, we are required to inform you that the U.S. Department of Commerce requires that US companies who export products do so in accordance with applicable US laws. These laws control export of US goods to ensure that they are not sold or resold to entities engaged in certain prohibited activities or sold or transferred to restricted countries. Failure to comply with these laws and regulations may result in severe penalties for the party exporting or re-exporting the goods. Restek seeks to condition its sales with the understanding that our purchasers will comply with these laws and regulations.

We ask that you please circulate this memo to all appropriate personnel within your organization.

Should you have reason to believe that Restek products are being used directly or indirectly in a restricted manner or being sent to a restricted entity or destination please contact us immediately.

## Export Control Summary

United States export regulations control the sale, transfer, export or re-export of Restek products. These regulations keep restricted or dual use items from being sold or transferred to certain countries, entities and persons. They also prohibit the use of these products from supporting certain end uses.

All Restek customers and partners agree not to export, re-export or transfer any commodities, software or technology, directly or indirectly, to any restricted country or any person, organization or entity on any of the restricted party lists maintained by the U.S. Departments of State, Treasury or Commerce, without the appropriate U.S. Government approval. Furthermore, Restek products should not be sold to any end user for the purpose of any prohibited end use as determined by the U.S Government.

Below is more information regarding the prohibited destinations, end users and end uses.

### Prohibited End Uses

Chemical or Biological Weapons	Product or technology to be used in the design, development, production, stockpiling or use of chemical or biological weapons and their precursors.
Missiles and Missile Technology	Product or technology to be used in the design, development, production, stockpiling, or use of missiles or missile technologies.
Nuclear end-uses	Product or technology to be used for nuclear explosive activities or safeguarded and unsafeguarded nuclear activities.
